### 1. Eligibility Criteria:-

i) Applicant must be a Law Graduate from any recognized University. ii) The applicant must possess a Degree of Law from a recognized University and be a registered legal practitioner. iii) Retired PP/APP and advocates having served or on Government panels tendering legal advice in criminal matters may also apply. iv) Age Limit: The candidates should not be more than 64 years of age on the date of engagement.

#### 2. Responsibilities(nature of job) :-

A) In matters where FIR has been registered

1. To tender legal advice to the Investigating Officers during: (i) All stages of investigation i.e. from the registration of case to the filing of charge sheet. The work will also include help in drafting legal papers. (ii) To provide legal advice in Bail matters and Misc. maters in various courts, including Hon'ble Supreme Court and High Courts.
